ABOUT HONORARY LIFE MEMBERSHIP

In accordance with article 5.2.4 of the USU Constitution the Board may confer Honorary Life Membership by Special Resolution upon any person who has made an extraordinary contribution to the Union or the University community. It is our highest award.

Recipients will have made an outstanding contribution over a considerable period of time by assisting the Union in the execution of its aims, and working towards the fulfillment of its vision and mission.

Honorary Life Membership also offers members an opportunity to put forward someone they feel is worthy of this recognition.

A maximum of four awards are made in any one year.

Nominations may be made by any member or group of members (including Life Members), however recipients do not need to be alumni of the University of Sydney; nor are they required to be Members of the Union.

Nominations will be considered by a selection panel consisting of current Board directors, prominent alumni and senior Union staff. In addition to the above, the selection panel will give consideration to the contribution made by the individual and the length of time over which that contribution has been made or will have effect.

The information supplied in the nomination submission will be verified where possible by the USU administration. The USU reserves the right to use information supplied in any USU publication, website or sponsor's website for promotional purposes.

Nomination Guidelines

Please attach a separate document outlining why you think the person you are nominating deserves to receive Honorary Life Membership.

The document should be typed and of no more than 500 words.

Dot points are encouraged as is the use of your company letterhead, if appropriate.

You may also attach a copy of the candidates CV, so long as the total submission is no longer than four typed pages. You should supply the contact details of up to two other people to act as referees for the nomination.

You should include examples of the person's work for the USU Community and the ways in which they have supported the Union in achieving its Constitutional objectives and mission.

Who can nominate?

- Students, staff and alumni of the University of Sydney Union may nominate someone for this award.
- Nominees need not be members current, former or life members of the USU.
- Nominees *may not* nominate themselves.
- Members of the USU Awards Committee *may not* nominate for the award.
